An open letter reply to Garrick

Dear brother Garrick,

Burdened by this great light which opens to all the *Righteousness of Christ*, three years ago you and others in your group chose to reject my Bible-based counsel.

Earlier this month, you reopened communications declaring to me by E-mail your yearning desire to understand the doctrine of the *Righteousness of Christ*. You may recall that you wanted a simple explanation. Though your request was probably broadcasted to a larger group that contained my name and though it was not specifically addressed to my ministry, it nonetheless flashed upon my E-mail screen. I had no way of knowing if this was a conscious or a subconscious appeal for my help. I do know that with Heaven's providence, there are no Freudian slips or coincidental encounters. Especially is this true since I am the Lord's elect, the one chosen to deliver the counsel for which you so desperately sought. The MSA is the only voice in Davidia that can answer your desire for knowledge on your question pertaining to *Righteousness by Faith and Grace*; there is no other voice on earth; thus, per the frustration expressed in one of your follow-up E-mail replies, your question yielded no response (see your E-mail Tuesday 03-Aug-2010). Therefore, I considered your plea for light to be a providential, heavenly-engineered petition for my direct and personal help.

Sadly, you seem unappreciative for the answer that heaven has rushed to your computer screen. Your negative reaction to heaven's providence is an indication of the phony, duplicitous, and disingenuous nature of your heart and of your request. Your lack of appreciation for heaven's preparation-day manna is expressed in your following reply to me:

*"I mistakenly sent you an e-mail recently with the names and e-mail addresses of people I know. They have asked me to personally request that you delete their contact information from your e-mail box. Please abstain from sending these individuals any more e-mails, and please delete their information from (sic) your e-mail address book. Please look over the list you've fished from (sic) my e-mail and scrub your system of them. Again, I hope you'll do the right thing, and don't use my e-mail contacts. When I noticed that BCC was not employed, I immediately send out a warning. Now this is an alarm--they do not welcome e-mails from you or Vinnette West, so please remove them from your e-mail directory. And while you're at it, please remove my name and e-mail address from your address book too. Thank you very much. . . P.S: Please confirm to me by e-mail that you've deleted 'all' the e-mails you've fished from my mails, especially the one discussing Law and Grace, the Sabbath School Lesson." —Monday, August 09, 2010 11:17 AM.*

My Gospel commission is to open up to Davidia (the church) the righteousness of Christ and to show them the distinction between His righteousness and the path to which they now follow —thus showing that which you call a "mistake" was no coincidence. Your request of me to not teach new students, by virtue of my religious commission, cannot be honored; after all, this is not Communist China; furthermore, David does not besmirch the Lord's graces. You say that my involvement was a mistake; yet, my keen, heaven-wrought instinct for advancing the Gospel leads me to believe that this presumed stumble from you was a blessing from heaven that you, one at war with Christ, only assume to be a tragic accident. I can hear the anxiety in your E-mail voice, and I am sorry to say that, for the enemies of Christ, the anxiety is about to get much more dreadful. Yesterday, you may have honestly committed to serving Christ, and by your free volition, He has employed you and others with whom you associate for this simple purpose, that of compiling the list of names in order to deliver to His anointed, David, the fruits of your work. This is why you then assumed the name, *Heralds of the King*; you, believe it or not, pledged to become my herald. [**Herald: an official...with duties including the making of announcements and the marshalling of combatants b: an**

officer with the status of ambassador acting as official messenger between leaders —Webster] Again, I consider your delivery to me of this list to be a **GRACE** from the Lord, a second chance at salvation. Let this be a lesson to you; let it serve your need to understand the term *Righteousness by Grace*. You received unmerited favor, unmerited because you rejected the Lord's appeal three years ago. To delve even deeper into the matter, this grace was not just extended to you; it was also extended to me, the Lord's *mustard seed*. Consider as validating evidence of this point two of many such lessons in Scripture: Did not David inherit Saul's wives as well as the wealth of Nabal, the wealthy, yet churlish shepherd of Carmel (See *2Sam 12 & 1Sam 25*) after they became enemies to Christ? Every grace that you have been awarded in your pretentious service for Christ will be delivered to His *mustard seed*. Do you not believe this? Or do you assign for yourself the mistaken way of Judas: Do you think it to be possible to betray Christ and keep the fruits of your gains?

I tell you in all sincerity that your release of names is not a coincidence. It is no coincidence that, for the last few weeks, a time before your E-mail, I have given studies on this very issue of your expressed curiosity, *Righteousness by Faith*, and that I intended to hold a seminar on the 21<sup>st</sup> of this month to give to all the answer for which you pleaded. After all, for 80 years now we have been warned of this hour as the Bible says, "*The Lord's voice crieth unto the city, and the man of wisdom shall see thy name: hear ye the rod, AND who hath appointed it*" —Mic 6: 9. Next, VTH sermonized from this theme by saying,

*"The Lord declares that His voice is crying to the city (to the church), and that the men of wisdom shall see the name, and shall hear the Rod and Him Who hath appointed It...I for one cannot overlook, neglect, or reject the Lord's counsel in this matter. I must hear the Rod and Him Who has appointed it if I expect to have a home in His Kingdom"* —1TG 27, 7(capitalized pronouns, He and Who, expressing deity belong to the quote ).

VTH agrees with the Lord and with the MSC: He taught that we Davidians must hear two messages, one entitled the *Rod*, and the other from Christ, Him Who has appointed the *Rod*. Hence, again as my herald, you must work with me on this; you must now live out the truth of your profession; you must now submit to the knowledge of *Christ our Righteousness* and work to broadcast it. I realize that many on your list whom you desire to shield from this light will do as you so desire by running to the rocks to hide their faces; after all, the hour is late and the gentle demeanor of our wayward brethren is about to be transformed into hysteria, into "weeping and gnashing of teeth". But your list will still have won the day for Christ because, at least then, they will have no excuse; they will stand before the Judge speechless: They cannot say that they did not know the truth about *Christ our Righteousness*. After receiving your list this past week, I sent to them a document on the Atonement. It is 60 pages long and is full of revelations about grace, faith, and righteousness. It reveals these themes through new light on the Bible theme of the Atonement especially as described in *Lev 16*. The wise on your list will carefully peruse that document and learn the answers which you, Davidia, and the SDA ministry cannot teach them. So you see, regardless of what you think or presume, that document took countless hours of Bible study and writing to forge; yet, Christ has freely endowed them with this knowledge; consequently, my work is indeed one of *Righteousness by Grace*.

Finally, your last E-mail expresses your great duplicity, confusion, and hypocrisy: You ask me to remove your name from my E-mail list, then, later on, as a post script at the very end of your letter, you ask me to notify you by E-mail of my compliance with your request. Do you not discern that the two requests are contradictory? Instead of compliance to that confusing message, this is what I will do: I will wait for your reply to this E-mail before I delete your name; meanwhile, I will also forward this letter to the list of names that you have delivered to me. I cannot comply with your request to delete their names since I do not now deem you to be a man of righteousness, grace, and integrity who would or could honestly represent the wishes of all the names on that list.
